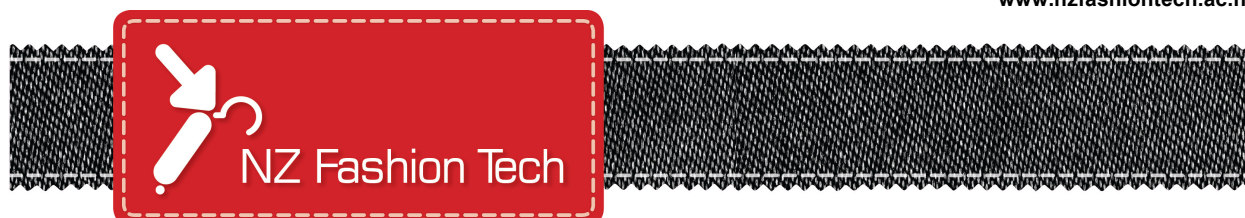

- Units 17914 and 17915 do not require specialist knowledge of teachers, industry or Gateway staff
- The 20 day component in Unit 17914 includes attendance at both school and work experience\*
- Students must complete a work experience placement but work experience hosts are not required to teach or assess – all they do is complete an attestation form
- Unit 4838 requires some clothing industry knowledge. If necessary, NZ Fashion Tech is able to offer professional development to enable you to deliver and assess this unit
- Unit packages include Student Workbooks and information booklets (if applicable), and comprehensive Teacher Guide and Marking Schedules
- Workbooks are marked by you using the Teacher Guide and Marking Schedules supplied – return them to us for moderation and signing off by our industry assessors
